Objective: FITT, IIT Delhi invites proposals from experienced companies specializing in providing delivery of hardware infrastructure with installation within the state of Odisha for setting up of Centres of Excellence for learning (CoEL) in the following domains: - (i) Artificial Intelligence Basic Builder, (ii) AI powered Blockchain, (iii) AI powered Augmented Reality/ Virtual Reality (AR/VR) Computer Vision Builder, and (iv) AI powered IOT & 5G builder (Total CoEL – 04) as part of Skill Development Program.

Scope of Work:

The selected company is expected to perform the following tasks: -

1. **Establish Centre of Excellence (CoE):** -

- Deploy 120 Laptops / Notebooks which are to be used by 4000 students as per specifications in succeeding paragraphs.
- The Laptop / Notebook should be **Make in India**, with limited components of foreign origin.
- Should be compatible with online lab environment.
- Deploy 08 x wall mount 42” display screen for Slide / presentation as per specifications in succeeding paragraphs.
- 04 x 100 Mbps speed with unlimited data broadband connection for one year (one connections per CoEL).

Hi Speed Broadband Connection:-

A Hi-speed internet connection along with Wi-Fi Router to support 40 hosts simultaneously with Min 100 Mbps speed and unlimited data (Data on fiber is preferable) with one year plan. The Wi-Fi router should have a minimum one year warranty and be able to cover an area of 2000 Sq feet over dual Wi-Fi band. Bidder/firm will ensure installation and integration.

2. Installation, Setup & Delivery: -

- The bidder/ firm will be responsible for Installation/setup all the hardware for effective online training and management.
- The bidder/ firm will deliver hardware items across earmarked locations Odisha.

3. Warranty and Operationalization: -

- Provide a one-year 24x7 warranty covering technical support, updates, and maintenance.
- 12 hour response time in any downtime for smooth functioning of the lab.

Eligibility Criteria for Companies:-

- Should have provided similar contracts.
- Previous Supply order with govt agencies/ reputed organizations is preferable.
- Provide No Malicious Code certificate (Mandatory).
- Annual turnover during FY 2023-24 should be over Rs 30 Lakh (Audited Balance Sheet / Provisional Balance Sheet / Copies of Purchase Orders to be provided).

Submission Requirements: -

Interested companies should submit their proposals by **20 Aug 2024**. Proposals should include:

- Company profile highlighting experience in computer hardware projects with Govt agencies for education/training.
- Detailed approach for setting up the Lab as per project requirements.
- Proposed timeline and milestones for implementation.
- Cost breakdown covering each of the above requirements including Hardware, Installation/setup and Internet connection.

Evaluation Criteria:-

Proposals will be evaluated based on the following: -

- Experience and expertise in providing IT Hardware solutions.
- Clarity and feasibility of the proposed approach.
- Alignment with project objectives and requirements.
- Cost-effectiveness and value for the proposed services.
- Past experience of setting up and running a similar training/ operational setup, documentary proof of the same needs to be submitted.

Payment Terms and Timeline:

Milestone 1: 90% Payment post-delivery and satisfactory installation of all hardware at consignee locations (within the state of Odisha).

Milestone 2: Balance 10% payment would be made on receipt of project completion report, final tranche from the sponsor, and compliance to all warranty regulations.

Note: Payments can be made only in case of remittances received from sponsor. In case of delay in payment from the sponsor, payments would be made post receipt of funds from the sponsor.

Pre-Bid Meeting: Pre-Bid meeting will be held at FITT, IIT Delhi on **01 Aug 2024** to clarify vendor queries and arrive at a common understanding. It is compulsory for all bidders to attend the pre-bid meeting, failing which their bids will not be accepted.

TERMS & CONDITIONS

Preparation of Bids: The offer/bid should be submitted in two bid systems (i.e.) Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid

Opening of the Tender: The bid will be opened by a committee duly constituted for this purpose. The technical bid will be opened first and it will be examined by a technical committee (as per specification and requirement). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification.

Acceptance/ Rejection of bids: The Committee reserves the right to reject any or all offers without assigning any reason.

Two separate sealed envelopes to be submitted for technical and financial bid (clearly labelled as “TECHNICAL BID” and “FINANCIAL BID”) respectively.
