- The contractual appointment will be initially for 3 months, which on satisfactory performance may be extended to one year and the subsequent year (up to max. of 2 years).
- If selected, the candidates who are currently employed should submit “No Objection Certificate” from the present employer.

- The work experience will be counted after acquiring the basic minimum qualifications and against authentic certificate from the past/present employer.
- On the date of the written test/ interview, the degree certificates and experience certificate should be provided in original for verification.
- No TA/DA will be paid for attending the written test or interview.

Application/Selection process:

- The applications will be shortlisted based on the educational qualifications, academic performance and the experience. Only the candidates who meet the shortlisted criteria will be called for written test. The date and nature of the written test and the venue will be communicated with the shortlisted candidate through email.
- Only the candidates, shortlisted based on the performance in the written test, will be informed and will be called for a personal interview by the selection committee.
- No communication will be made with candidates whose applications do not meet the shortlisting criteria or who do not qualify the written test.
- The post may be downgraded as per discretion of the Selection Committee if none of the candidate is found suitable for the post.
